1. Withdrawal Information

Right of Withdrawal

You can withdraw from the contract within 14 Days - without the need to indicate a reason - by sending us an Email or by returning the items BEFORE the end of the 14 Day withdrawal period.

The 14 Day withdrawal period starts after you reveice this withdrawal information but not before you receive your order. The Withdrawal has to be send to:

Withdrawal Consequences

In case of a valid withdrawal you need to send us all items back and we will return your payment.

You have to cover shipping costs for returning the ordered items.

Payments must be returned within 30 Days. The 30 day period starts for you with sending your withdrawal declaration or returning the items, for us with receiving it.

End of Withdrawal Information

Custom machined parts or Armatures can not be returned.
